### Introduction

Generally, Children's Charities and Associations assist in the protection of babies, children, and adolescents who are victims of abuse or who are in danger of becoming victims of abuse, whether it be physical, emotional, sexual, or the result of neglect or abandonment. They also give aid to families that need more assistance and support. Making sure children can remain with their families while being safe and thriving is a top priority for all Children's Charities.

Families are frequently confronted with challenges such as poverty, unemployment, addiction, mental health challenges, and insufficient housing, all of which can add additional pressures and complexity to their already stressful lives, impairing their capacity to provide for their kids. For example, a kid may well be suffering from neglect due to their family's financial and housing status, or the family may require children's support as a result of a parent's mental illness.

According to a World Bank analysis released in 2021, over 40% of all children under the age of primary school – or almost 350 million – require childcare but do not have access to it. As a result, an excessive number of children are forced to spend their time in hazardous and uninspiring situations. The COVID-19 epidemic has brought shortcomings in childcare services and the sector's susceptibility to the forefront of public debate throughout the world.

Investing in high-quality, affordable childcare is critical to removing barriers to upward mobility, assisting everyone in realizing their full potential, and advocating equity – which is an essential component of global economic growth and productivity, and its overall competitiveness.

The challenges encountered by society's most vulnerable groups have been more difficult to overcome during the past three decades as a result of rising inequality in various countries around the world. Children, in particular, are suffering as a result of this circumstance. The current situation of child vulnerability places emphasis on investing in the well-being of vulnerable children as a vital activity for achieving inclusive global development.





### Factors Influencing Child vulnerability

Over time, multiple factors combine to make children vulnerable to abuse and neglect. For instance, children in poverty may also live in high-poverty neighborhoods where social capital and social cohesion are lacking. Children who are homeless face a variety of challenges, including housing insecurity as well as the mental health of their parents and the breakup of their families.

Young children are particularly vulnerable to the effects of domestic violence due to their critical period of development, high level of dependency, and increased concentrations of time spent in the home setting. As a result of a lack of financial resources, children with impairments may struggle to succeed in school.

Maltreatment affects children from all socioeconomic backgrounds, but those from low-income families are particularly vulnerable because they lack the necessary safeguards like a safe living environment, good educational and child care options, and strong social and family ties to keep them safe from harm. The interplay of elements that contribute to a child's vulnerability necessitates a holistic approach to well-being throughout infancy.

#### **Disability**

Physical, intellectual, communicative, and sensory impairments and chronic diseases impede the functioning of children with disabilities. Children with disabilities are heavily represented in institutional care and more likely to suffer abuse, especially neglect. Children with disabilities are more likely than non-disabled peers to live in low-income families and be bullied.

#### **Immigration Factor**

Immigrant children are a vast and increasing group. Factors like parents with less education and financial resources might impact their children's capacity to complete school. They also belong to fewer social networks in their host community, speak a different language at home than at school, and are more mobile than pupils without an immigrant background. Across countries, native-born pupils do better academically; the disparity between children of immigrants is greatest for children arriving after the age of 12.

#### Depression and other mental health issues

Disparities in children's mental health can be traced back to social inequity. Two to three times as many children from poor socioeconomic settings suffer mental disorders as those from higher socioeconomic backgrounds. Parent-child transmission and a parent's lower socioeconomic status are also influences. More educated parents are better equipped to provide timely and specialized assistance to their children.

#### Maltreatment

Poverty, living in a rough neighborhood, overcrowding, parental substance abuse and intimate partner violence are environmental risk factors for maltreatment. It's tough to identify children at risk because many aren't maltreated. Individuals and society suffer long-term economic costs of maltreatment. Growing children that have been maltreated are less likely to be educated, earn less, and possess less.

The Children's Aid Token (\$CAT) is a community-driven token with a global aim to assist children and their families in need. \$CAT has been created to reward our community, aid in our charitable mission, and serve as a utility token within its ecosystem, among other purposes.

\$CAT is a Bep20 token built on the Binance Smartchain Network.

\$CAT smart contract has been designed to charge a transaction fee of 9%. This will occur after \$CAT has been listed on PancakeSwap rather than during the pre-sale period.

The following is how the fee will be distributed



#### Passive Income for holders

All \$CAT holders on decentralized wallets will receive 5% of the transaction fee from the \$CAT smart contract.



#### Maintain a Price Floor

3% of all transaction fees will be added to the PancakeSwap liquidity pool in order to maintain a price floor.



#### Helping charities


In our mission of assisting charities, 1% of every transaction fee will be transferred to the charity wallet.

#### Why Presale

There are 3 main reasons we are conducting a presale for \$CAT:

1. To give our early investors a chance to bag \$CAT at a much lower price before public sales (at the point which the price will surge)

- 2. To create the much-needed awareness in preparation for public sales.
- 3. To raise funds that will support the development of project's next stages.

#### **How Presale works**

The smart contract for the \$CAT presale is timed. If we cannot raise the desired amount, we may be obliged to conduct another public presale.

We are offering to the public a massive 55% of the total token supply, giving the community an early opportunity to purchase the token at a lower price. During pre sale, no fees are collected from the buyers. On top of it, we offer a woopping 20% additional \$CAT tokens for free on every transaction.

In exchange, we intend to raise 1250 BNB, which will be used to offer token liquidity, assist with the development of CATswap, and fund paid marketing campaigns.
